This Privacy Notice outlines how MSA Resources Sdn Bhd ("MSAR") collects, handles and stores your information in line with the Personal Data Protection Act 2010 ("PDPA"). We value your privacy and place high importance on the security of your personal information. 1. Our commitment to your privacy
